4. Copies of Passports of the founders, main shareholders, ultimate beneficial owners, members of the MGA's board of directors, and its executive managers.
5. Binding Authority Agreement (BAA) concluded with each reinsurer.
6. Letter of Authority from each contracted reinsurer, signed and stamped by both the reinsurer and the managing general agent.
7. Latest Audited financial statements.
8. MGA's business plan and its target business volume within the Egyptian market.



9. A copy of the Professional indemnity insurance policy issued by an Egyptian insurance company, with a liability limit of EGP 40 million.
10. A declaration of compliance with the legislations related to the MGA's activities, as well as those related to combating money laundering and terrorism financing
11. Proof of payment of amount EGP 25,000 (Net of any charges) or its equivalent in foreign currencies approved by the Central Bank of Egypt, for the review and assessment of the registration application.
12. Authorization Letter/Power of Attorney (POA), if the application is submitted through the MGA's legal representative.
